Alex O'Connor Joins L&L Holding Company as Acquisitions Associate

L&L Holding Company, one of New York City's preeminent commercial real estate owner/developers, announced today that it has appointed Alex C. O'Connor as an associate in the firm's acquisitions department, effective June 19th.

O'Connor will join L&L's acquisitions team headed by Senior Managing Director of Acquisitions, Yong W. The appointment of O'Connor continues the hiring surge at L&L in recent months. Over the last several weeks, L&L has appointed David Orowitz as senior vice president in the company's development division, hired Adam Metzger as vice president in the acquisitions department and promoted Jim Traynor to serve as project manager for 390 Madison Avenue.

O'Connor received two Bachelor of Science degrees in Finance and Real Estate from Florida State University. He is a member of the Urban Land Institute and NYPEN, and is actively involved in the iMentor mentorship program for students in low-income communities.
